 - **FY25/26 5311 Ops: \$5,192,749** (\$4,114,024 in FY23/24; +26.2% FY25/26-over-FY23/24)
 - FY25/26 5339 Capital: \$640,000 (For purchasing of up to four (4) electric light-duty transit vehicles (e.g., 10-14 passenger, ADA-equipped electric transit vans) that will be deployed in MRTA's existing, continuing, and growing operation of 5311 Service, CHT Service, and ADA Paratransit Service; 80%/20% cost sharing)
 - FY25/26 CARES: \$350,000 (For underwriting Mountain Rides' existing and continuing operation of CHT Service connecting riders in the Wood River Valley with medical/health care services providers in greater Twin Falls, Idaho; 100%/0% cost sharing)
